Jo is an Associate Professor in Evidence Synthesis. Since 2009 Jo has led the PenCLAHRC Evidence Synthesis Team where she is involved in producing systematic reviews and evidence syntheses to inform locally relevant evidence based practice. The Evidence Synthesis Team also plays an integral role in the identification and prioritisation of research projects for development within the South West peninsula in the UK. Jo has extensive experience of performing systematic reviews and evidence syntheses spanning both qualitative and quantitative approaches and encompassing a wide range of study designs. Recent activities have centred around methods for conducting reviews of

implementation studies and include an overview of systematic reviews of implementation studies, and reviews of implementation and dissemination in dementia care and in the care home setting.
