## Note:

- 1. Members may be asked to attend at any of the 3 panels if quorum is an issue.
- 2. All TOH/OHRI and UOHI staff and physicians must undergo mandatory Privacy/PHIPA training which includes annual refreshers. Therefore any member affiliated with TOH, OHRI or UOHI would be able to fulfill the role of "Knowledgeable in Privacy/PHIPA".
- 3. A member may be able to represent multiple roles at a meeting; however, REB members may not wear more than 2 hats at a meeting.
- 4. The OHSN-REB has mandated that all investigators (QI or Co-I) must show proof of TCPS 2, GCP, and Health Canada Division 5 training in order to obtain REB approval for their interventional research project. It is also recommended that all research coordinators undergo the same training; however it is not required for approval. Therefore, any REB member who is also an OHSN-REB applicant should be considered as a member "Knowledgeable in Research Ethics". These members are identified by a '≠' in the final column.
