Note:

- 1. Members may be asked to attend any of the 3 panels (Civic Campus, General Campus and University of Ottawa Heart Institute Campus if quorum is an issue.
- 2. All TOH/OHRI staff and physicians must undergo mandatory Privacy/PHIPA training which includes annual refreshers. Therefore any member affiliated with TOH, OHRI or UOHI would be able to fulfill the role of "Knowledgeable in Privacy/PHIPA".
- 3. TOH/OHRI and UOHI staff and physicians complete the mandatory annual refresher in Privacy/PHIPA Training as per institution requirements.
- 3. An OHSN-REB member may be qualified for multiple roles, but can only satisfy a maximum of 2 roles per meeting.
- 4. The OHSN-REB has mandated that all investigators (QI or CO-I) must show proof of TCPS2 and GCP in order to obtain REB approval for their interventional research project. It is also recommended that all research coordinators undergo the same training; however, it is not required for approval. Therefore, any REB member who is also an OHSN-REB applicant should be considered as a member "knowledgeable in Research Ethics".
