#### SUMMARY OF CONTRIBUTIONS TO SCIENCE

#### Policy

- My team conducted some of the initial work describing the relationship between governance systems and the delivery of public health programs. I have served as an expert/consultant for multiple Canadian reports (three federal Auditor General Reports, Report of the National Advisory Committee on SARS and Public Health, testimony to the Senate Sub-Committee on the 2008 Listeria outbreak) as well as twice serving as a consultant to the World Health Organization examining the International Health Regulations.
- Our work on vaccine policy and consultation with the Vaccine Task Force directly led to the introduction of Canada's Vaccine Injury Support Program.

#### Science

- My team authored the seminal papers on <u>social media</u> and the spread of vaccine misinformation.
- Supported by the Bill & Melinda Gates Foundation, my team developed a metabolic algorithm that can estimate the gestational age of an infant at birth with a high degree of accuracy. In partnership with Stanford University this algorithm is being applied in multiple global settings where prenatal ultrasound may not be available.

#### Innovation

- My team have been leaders in digital immunization solution innovation. My team developed the world' first digital immunization record, the first digital reporting of immunization status, the first pan-Canadian standardization of vaccine terminology, the first digital reporting of adverse events following immunization in Canada, the first proof of concept mobile barcode scanning of 2D vaccine barcodes solution and were the first to introduce the concept of digital immunization passports.
- At the Ottawa Hospital my team created the Ottawa mHealth Lab which supported scientists in developing digital solutions to improve patient care.
- At Bruyère I have supported the development of an innovation agenda to help test commercial solutions in healthcare.
